



## **SABER LIMITED WARRANTY**

### **New Product Manufacturer's Warranty**

All new products sold by A.R. Tools under the brand name of "Saber" are Warranted against defects in design, materials, and workmanship for a period of one (1) year from the date of pick-up or delivery to the end user and/or purchaser. This Warranty covers parts only and in no way is labor or freight charges covered or included in this Warranty. If it is determined by A.R. Tools and the Manufacturer that a defect is covered under this Warranty, the product will be repaired or replaced, at the discretion of the A.R. Tools and/or the Manufacturer, per the terms of the original factory / manufacturer's Warranty.

### **Seller's Warranty on Repairs**

Repair or replacement costs, which are not covered under this Warranty, shall be paid for by Customer. All products repaired or replaced under this Warranty by A.R. Tools will be Warranted against defects in material and workmanship for a period of one (1) year from the date the repair is completed or the remainder of the Manufacturer's Warranty, whichever is longer.

### **Limitations**

A.R. Tools' Warranty does not extend to products subject to (i) improper installation, connection, operation, maintenance, or storage by Customer; (ii) accident, damage, abuse, or misuse; (iii) abnormal or unusual operating conditions or applications outside the specifications for the product; (iv) a purpose or application in any way different from that for which the products were designed; or (v) repairs conducted by persons other than A.R. Tools employees or an authorized representative. A.R. Tools does not cover labor costs for repairs, customer "down time" during repairs, or any consequential damages or costs related to or as a result of repairs. Shipping, freight, and transportation costs, return or otherwise, are not covered by nor are a part of this Warranty. All freight and/or shipping costs are the responsibility of the purchaser.

**THIS WARRANTY IS IN LIEU OF ANY OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING WITHOUT LIMITATION, ANY WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, AND IS IN LIEU OF ANY AND ALL OTHER OBLIGATIONS OR LIABILITY OF A.R. TOOLS. UNDER NO CIRCUMSTANCES SHALL A.R. TOOLS BE LIABLE FOR ANY ACCIDENTAL OR CONSEQUENTIAL DAMAGES OR FOR ANY OTHER LOSS, INJURY, DAMAGE, OR EXPENSE OF ANY KIND INCLUDING LOSS OF PROFITS ARISING HEREUNDER.**

To the extent any court, arbitration panel, or other governmental body of competent jurisdiction shall declare any provision of this warranty invalid or unenforceable by reason of a rule of law or public policy, all the other provisions hereof shall remain in full force and effect.
